ORDINANCE OF THE MAYOR AND COUNCIL OF THE BOROUGH OF FREEHOLD, COUNTY OF
MONMOUTH AND STATE OF NEW JERSEY
AMENDING AND SUPPLEMENTING CHAPTER 10 (TRAFFIC),
SECTION 10.08.040 (STOP INTERSECTIONS) AND
BY AMENDING CHAPTER 10.44 TRAFFIC SCHEDULE IX (STOP INTERSECTIONS)
OF THE REVISED GENERAL ORDINANCES OF THE BOROUGH OF FREEHOLD

WHEREAS, the Freehold Borough Police Department has recommended that the intersection of Center Street and Jackson Street be regulated by stop signs on all corners; and

WHEREAS, the Mayor and Council have determined that it is in the public interest to revise the Ordinance pursuant to the recommendation.

NOW, THEREFORE, BE IT ORDAINED by the Mayor and Council of the Borough of Freehold that Chapter 10.08.040 (Traffic) (Stop Intersections) and Schedule IX (Stop Intersections) as set forth in Chapter 10.44 are hereby revised and supplemented by the addition of the following:

Section I

Chapter 10.08.040 (Stop Intersections).

In accordance with the provisions of N.J.S.A. 39:4-140, Chapter 10.08.040 (Stop Intersections) is amended to reflect that the intersection of Center Street and Jackson Street be regulated by stop signs on all corners.

Chapter 10.08.040 (Traffic Schedules) Schedule IX (Stop Intersections).

Schedule IX shall be amended by adding the following described intersection which is hereby designated as an all-way Stop Intersection. Stop Signs shall be installed as indicated:

Center Street and Jackson Street

Install STOP sign(s) on all corners of Center Street and Jackson Street

Section II

If any part of this Ordinance shall be deemed invalid such part shall be deemed severable and the invalidity thereof shall not affect the remaining part of this Ordinance.

Section III

Any Ordinance or portions thereof which are inconsistent with the provisions of this Ordinance are hereby repealed and superseded.

Section IV

This Ordinance shall take effect upon final passage and publication in accordance with Law.
